Dear Ms. Molchanow:

Admiral Peary AVTS (APAVTS) is requesting to change our current attendance area, specifically to admit the Harmony Area School District (Harmony). APAVTS currently has fourteen PDE approved CTE programs with an approximate enrollment of 500 students. The addition of Harmony to the APAVTS attendance area will have a projected increase in enrollment of ten to fifteen (10-15) students. This small enrollment increase will not affect the ability of APAVTS to continue to serve and offer all PDE approved CTE programs to all current members as well as Harmony. Enclosed is a listing of all currently approved CTE programs offered at APAVTS.

The addition of Harmony to the APAVTS attendance area would have a favorable fiscal impact for APAVTS and its member. The enrollment increase will reduce the cost per student as well as result in increased income for APAVTS. As a member of the APAVTS attendance area in addition to tuition, Harmony would also be responsible for a portion of all capital improvements and expenditures.

Enclosed is a copy of the APAVTS Joint Operating Committee (JOC) minutes from the March 15, 2018 Regular Meeting authorizing the preparation of a proposed amendment to the JOC Articles of Agreement to admit Harmony as a member of the APAVTS and to issue the proposed amendment to the current seven member school districts for a vote by their respective members. Additionally, copies of the letters from all current member school districts approving the admittance of Harmony as proposed are enclosed.


