CHAIRPERSON'S REMARKS

Mr. Torsella thanked the leadership of the Chester County Technical College High School for their hospitality in hosting the Board, and Senator Dinniman for welcoming the Board to Chester County.

APPROVAL OF THE MINUTES

Upon a motion by Mr. Larry Wittig, seconded by Ms. Sandra Dungee Glenn, the minutes of the January 28, 2010 meeting of the State Board of Education were approved by unanimous voice vote.

REPORT OF THE SECRETARY OF EDUCATION

Dr. Gerald Zahorchak updated the Board on the state's presentation of its Phase I Race to the Top application in Washington, D.C. Senator Dinniman noted the connection between federal reform efforts and the looming sunset of Pennsylvania's Empowerment Act (June 30, 2010).

Secretary Zahorchak also discussed the National Center for Education and the Economy's Board Examination Systems program. This initiative would allow students in

participating districts to graduate early based on demonstrations of readiness against international qualifying benchmarks.

The Secretary concluded by thanking the Board for its interest and work on school safety and climate issues.

PROFESSIONAL STANDARDS AND PRACTICES COMMISSION

A written report was provided to the Board by the Commission.

PUBLIC COMMENTS

There were no comments from the public.

ACTION ITEMS

A motion to non-renew the authority of the United Private Academic Schools Association of Pennsylvania to act as an approved accrediting association under Section 5 of the Private Academic Schools Act, with the provision that affected schools be notified and allowed ample time to obtain the approvals necessary to continue operations, was presented by Dr. James Barker and seconded by Mr. Larry Wittig. All were in favor as indicated by a unanimous voice vote.

A motion to amend the Board's bylaws by changing the titles of student representatives from "student member" and "student member-elect" to "senior student member" and "junior student member," respectively, was presented by Dr. A. Lee Williams and seconded by Ms. Sandra Dungee Glenn.

ANNOUNCEMENTS
