APPROVAL OF THE MINUTES

REPORT OF THE DIRECTOR OF THE BUREAU OF CAREER AND TECHNICAL EDUCATION

Dr. Lee Burket, Bureau Director, outlined information presented in her written report, including industry certifications, the technical assistance program, and accreditation. She noted that the Board was provided with a draft copy of the U.S.D.E. Accreditation Petition at the September 16 meeting for review. If the petition is approved by the Board, it will be submitted to U.S.D.E. for consideration. If approved, the petition will allow the Bureau to accredit postsecondary CTE programs. The Bureau began accrediting career and technical centers when the only previous accrediting organization—Middle States—discontinued its services.

Middle States has since re-entered the field of accreditation. The deadline for submission of our petition to USDE is June 2011 with a tentative hearing date of December 2011.
